## **Zoning and Development**

- 3-21-24 7412 Malaga Drive NE. Homeowner Travis Carpenter requesting a variance for a 6 foot wall around his yard. The property is within the North Wyoming NA boundaries. He sent notice to Cherry Hills NA and Academy North NA. Suzanna Flores from ONC said it is because North Wyoming is no longer recognized by the city, and so the IDO then requires notification be sent to any NA within 1,320 feet. So Cherry Hills and Academy North were properly notified. One Cherry Hills board member commented that it was interesting that we receive notification of something that does not affect us and is of no interest to us, but the city was not required to notify us of the dog park that is being developed at Heritage Hills Park which is literally in our backyard.
- 3-23-24 7748 Calle Comodo NE. Homeowner James Sullivan requesting a variance for his backyard kitchen which is too close to his property line. He just bought the house and the kitchen was already built. He asked the affected neighbors about it, and they were both okay. Vista del Norte NA was properly notified.
- 3-28-24 6721 and 6728 Akademeia Loop. Site plan for two more houses at Pulte Homes' Academy Estates. Cherry Hills NA properly notified.
- 4-3-24 8040 Academy Drive NE. Signart notification of new signage at on Smith's at Sycamore Plaza. Cherry Hills NA was properly notified.
- 4-8-24 8901 Holly NE. Architectural Signage Design Group notification of new sign for Allaso Vineyards. Vineyard Estates NA was properly notified.
- 4-12-24 Notice of Decision issued regarding approval of Master Development Plan and Major Amendments of Site Plan for Balloon Fiesta Park. Everyone was properly notified.
- 4-16-24 7425 Jefferson St. NE. Fastsigns notification of new wall sign for New Mexico Mortgage Finance Authority. Location is within boundaries of Alameda North Valley Assoc., but because it is no longer recognized by the city, the applicant is not required to notify them. D4C was properly notified.
- 4-17-24 Elizabeth Meek, president of Vineyard Estates NA, forwarded me and Mildred (as well as Nor Este NA contacts and 3 city planning personnel) email correspondence with Modulus Architectural Land Use Planning LLC asking that the preapplication meeting regarding the multifamily project at that intersection be facilitated. The applicant contacted the city and was told it was not required. I offered D4C support and/or assistance, but did not receive a response. Vineyard Estates NA and Nor Este NA appear to have been properly notified. However, I was unable to find that I had received the original notification from the applicant.
- 4-18-24 7330 San Antonio Drive NE. Dutch Bros Coffee applying for development of a new drive through coffee restaurant. The site currently has a closed gas station building on it. It will be right across the street from the new Human Bean drive through coffee restaurant at 7301 San Antonio. I shared the info provided to me with the developers of the Human Bean because I thought it was their business. I also gave Dutch Bros some unsolicited advice that they were putting a morning stop location on the wrong side of the street (traffic is going mostly westbound

in the morning), and that the construction of their competition was already almost completed across the street on the westbound side of the street. They thanked me for my advise and said they wanted to proceed. Cherry Hills NA was properly notified.

5-2-24 – Jim Griffee asked Vanessa Baca for some clarification regarding notification requirements in the IDO for recognized and unrecognized neighborhood associations. He was advised that applicants are required to send development notices to recognized coalitions per the boundaries of their member associations whether recognized or not. But while member associations of a recognized coalition do not have to be recognized, if they are not recognized, they will not receive notifications. So now we need to decide if we are obliged to pass on development notifications to our unrecognized associations.

Progress is occurring with the North Domingo Baca Aquatic Center, and I would like to provide an update. The current prepared dirt site, including what looks like a long sidewalk is really the top of more than 200 3'- 4' wide by 40' deep concrete piers and is the retaining wall engineered to support the integrity of the location. This is the first sub-grade retaining wall I have experienced, and it is necessary to move forward on this development. A Request for Proposal (RFP) is the beginning of the procurement process to determine which contractor will build this incredible and sizable project. The RFP has occurred, and it is my understanding the selection for construction of this project is likely going to be awarded to Bradbury Stamm. The Administration is currently in negotiations with Bradbury Stamm to determine next steps, and value engineer the design to achieve the desired results of building the indoor natatorium first. Full funding is required to begin construction any capital project in Albuquerque. This means we need all the quoted dollar amount to begin building the indoor natatorium and/or outdoor recreation pool. Once construction begins, which will hopefully be this year, it will take approximately 12-18 months to build.

The indoor natatorium is the priority for all involved, including constituents, the Administration and myself, while ensuring completion of the entire project is the goal.

This project began as a promise for a public pool in the Northeast Heights over 20 years ago. What was a dream of a providing a basic pool has turned into the design of a state-of-the-art facility providing aquatics for young children, families, athletes, those with disabilities, and seniors. It will increase quality of life, safety, recreation, athletics, and therapy while benefitting our local economy for all.

This long-awaited project has been a priority of the district since before I first campaigned five years ago. I have made more progress on this long awaited, and voter approved project than has ever occurred in Albuquerque history. Although things always take longer than estimated, I remain optimistic and dedicated to seeing this project to finality.

#### For those who want to help...

Instead of signing petitions that only explain a portion of the benefits and desires of the North Domingo Baca Aquatic Center, and reading partial truths and misinformation on social media, help me build more collaboration with Bernalillo County and Albuquerque Public Schools. Use your motivation and energies increasing the potential for funding and ensuring we achieve our end goal...which is to build a <u>full</u> aquatic center for our entire community.

**Subject: D4C Update** 

- 1. Council is currently reviewing the Mayor's proposed budget, which needs final Council approval by the end of the month. There will be a Committee of the Whole meeting on Thursday, May 16<sup>th</sup> where the Chair should have a proposed Committee Substitute to present, and Councilors may add additional amendments. Once passed at committee, the bill will proceed to the next Council meeting where additional amendments may be moved, and there will hopefully be final approval.
- 2. I am not at the Coalition meeting because we are having a LUPZ (Land Use Planning and Zoning) meeting at the same time. Although there are multiple agenda items, the big topic is the IDO (Integrated Development Ordinance) annual update. Last month's LUPZ meeting included presentations and discussion about proposed amendments. I anticipate we will vote on the proposed amendments at the meeting we are currently conducting, concurrent with D4C.
- 3. There are four Charter amendments being proposed to be placed on the ballot for voter approval. These are worth keeping an eye on, and reaching out with your opinion.
- 4. Councilor Grout and I have introduced a bill to amend our Immigrant Friendly City policy. It would allow city staff and resources to be used to contact federal authorities if a person is arrested and charged with a violent felony, human trafficking, or trafficking of narcotics. It would not allow city resources to be used to identify and work with ICE for any individual. We will hear this bill at FGO (Finance Government Operations) committee on Monday, May 13th. This is an online meeting on Zoom, available for all to attend. There will be a committee substitute proposed with some changes. Depending on the discussion, it will

move to full Council or remain in committee for more work and conversation. We are not trying to rush this proposal or target immigrants. We welcome immigrants to our city, but want to make sure to change the criminal friendly, sanctuary city reputation we have developed in order to protect <u>all</u> of our community.

5. There have been some vocal, not all correct, communication about the North Domingo Baca Aquatic Center. I have created a letter for you all to have for your use.

I am sorry we missed this meeting and will see you all soon.
